PROGRAM HIGHLIGHTS 2020

CLIMATE AND PUBLIC HEALTH

We will continue our pioneering strategic legal advocacy to address the climate crisis and protect our public lands and the health of our communities from the ravages caused by fossil fuels development. As we fight for a phase-out of fossil fuels, we will also advocate for a just, equitable transition toward a clean energy future that supports workers and their families.

Our work is exemplified by a high-stakes new federal lawsuit to overturn the sale of nearly two million acres of public lands for fracking in Colorado, Montana, New Mexico, Utah, and Wyoming. Last year we won a similar legal challenge, and we aim to win again.

In Montana, we will fight both coal mine expansions and ill-advised permits to pollute. We will work diligently to stop a 7,000-acre expansion of the Bull Mountains coal mine, a 6,500-acre expansion of the Rosebud strip-mine, and a 100-million ton expansion of the Spring Creek mine.

In New Mexico, we will lead an emergent, new coalition to combat oil and gas development in the Permian Basin, located in the southeastern part of the state. We will also continue our shared fight to secure the strongest possible protections for the sacred Greater Chaco Canyon, an area home to indigenous peoples threatened by ongoing oil and gas fracking. We will also work statewide to swiftly move New Mexico toward 100% clean energy and a just, equitable plan to support local communities and diversify our state's revenue and economy, a win-win for New Mexico's environment and families that can serve as a model for our entire country.

DEFENDING THE LAW

In another extreme assault to the environment, the Trump administration proposed a rule dismantling one of our country's most important, bedrock environmental lawsthe National Environmental Policy Act (NEPA). The proposed rule, if finalized, would allow more fossil fuel drilling and extraction on our public lands, reducing federal agency transparency and accountability to you, the public. In 2020, we will be leading coordinated efforts to fight this troubling proposal head-on.

PUBLIC LANDS

We continue to deepen our legacy of successful litigation protecting federal forests in Oregon, Colorado, Montana, and New Mexico. From watchdogging timber sales to active legal involvement in the development of once-in-ageneration land management plans, we will use the law to defend these public lands and the values they provide. We will also continue to protect and defend the expansion of the Cascade-Siskiyou National Monument in Oregon, our country's only national monument designated to protect native biodiversity.

CLEAN WATER

The Puget Sound shouldn't be a waste dump for pollution. Accordingly, we will take legal action to force the **Environmental Protection** Agency (EPA) and the Washington Department of Ecology to develop cleanup plans for Puget Sound and the thousands of rivers and streams in Washington state that have long been degraded by unsafe levels of pollution. Our waterways, communities, and wildlife have suffered for far too long, and it's time for real action to achieve clean water solutions.
