WINS FOR WATER AND PUBLIC HEALTH

STATE-LEVEL WATER PROTECTIONS

Our team worked with the New Mexico Environment
Department and legislators to craft SB 21, a bill to
establish a state framework to protect New Mexico's
waters from pollution and safeguard communities, wildlife
habitat, and the outdoor recreation economy. Our efforts
responded to the 2023 Supreme Court decision that
devastated the federal Clean Water Act, exposing 95%
of New Mexico waters to pollution risk. This year, Gov.
Michelle Lujan Grisham signed SB 21 into law, restoring
critical protections for New Mexico's waters.



Thanks to our intensive involvement, the New Mexico Water Quality Control Commission adopted a rule prohibiting the discharge of treated fracking wastewater into New Mexico's ground and surface waters. This waste contains thousands of chemicals, many toxic to human health and the environment. Big Oil is already trying to reverse this state ban on fracking wastewater discharge. We are fiercely engaged to defend the ban to protect New Mexico's waterways and public health.

PROTECTING WATER FROM TOXIC POLLUTION

In response to our steadfast legal advocacy, the Washington State Pollution Control Hearings Board ordered the Department of Ecology to—again—rewrite pollution discharge permits for concentrated animal feeding operations (CAFOs) to better protect water resources and public health. The prior permits still failed to control the heavy pollution from these factory farms. Our win will help protect drinking water and ensure public health in the context of a changing climate.





WINS FOR WILDLIFE

WESTERN WOLVES

Our legal team achieved a courtroom victory that makes a significant difference for wolves across the entire West. The court ruled that the U.S. Fish and Wildlife Service violated the Endangered Species Act when it denied federal protections to wolves in western states. Western wolves, including the currently delisted Northern Rockies wolves, will now be re-evaluated for Endangered Species Act protections and will have another chance of receiving the federal protections they need to recover across the West.



We proved that science—not politics—prevails in grizzly management. The U.S. Fish and Wildlife Service denied petitions from Montana, Idaho, and Wyoming to eliminate Endangered Species Act protections for grizzly bears. This decision allows grizzlies to keep their federal endangered species protections, affirming a prior WELC win. In another victory, the U.S. Fish and Wildlife Service created a new habitat conservation plan to prevent grizzlies from being killed by trains in the Northern Continental Divide in Montana. This new plan affects BNSF Railway Company trains on 206 miles of track through grizzly recovery zones.



CANADA LYNX

We secured a legal agreement with the U.S. Forest Service to protect important Canada lynx habitat in the Kettle River Mountains of northeast Washington from a proposed logging project. This logging project would also have impacted three roadless areas, logged 5,980 acres, and thinned 8,106 acres. Thanks to our involvement, the Forest Service will apply conservation measures in more of the Kettle "core" Canada lynx area and preserve the recreational and ecological values there.
